

Significant Events and/or Alarms

- April was an above average month again for alarms. So far this year, every month has been well above average for calls for service with the exception of February, which was normal. 2017 year to date alarms is 174, and same date in 2016 was 119.
- Also occurring this month is a pertinent negative: Not a single rescue call for a Motor Vehicle
 Accident on US 131 in the construction zone. So if you were thinking maybe the rescue calls on the
 highway are the reason for the spike- that would be a negative.
- On April 20 & 22, 2017, FF's Nielsen and Grady participated in the written and practical exams respectively for the MFFTC Fire Academy hosted at Plainfield FD. Both members successfully passed both exams. Congratulations Nick and Jordan!
- SFD personnel attended the annual Cedar Springs Community Night and reported very low attendance and even less foot traffic to the SFD table and or apparatus. There was not any positive leads for recruiting.
- On April 22, 2017 SFD responded to a barn fire @ 14631 Hanna Avenue N.E. at 1812 hours. On arrival crews found the roof of the barn collapsing from heavy fire involvement. Given the hour of the day, this fire made live coverage on the local Grand Rapids media channels as the column of smoke was visible from their tower antennae sites in GR. SFD was assisted by Kent City, Algoma, Sand Lake, and Cedar Springs Fire Departments. Mutual aid partners were on scene about 3.5 hours and SFD cleared around midnight. The cause and origin of the fire is undetermined and the estimated loss is \$300,000. This includes the loss of four classic cars and a motorcycle stored in the barn and two vehicles damaged outside the barn by conducted heat. As this barn was converted to a "man cave" over the years, it goes without saying that there are countless tools that were lost in the fire too. The residential dwelling is about 100 feet from the barn suffered some damage from heat transfer via convection. There were no civilian or fire service injuries or casualties. The homeowner is a firefighter with the City of Grand Rapids FD.
- On April 24, 2017 SFD assisted Kent City FD at a residential dwelling fire on 17 Mile Road near Payne.
 Aid was provided in the form of a Tender truck and personnel support. The fire started in the
 attached garage from improper disposal of pellet stove ashes and quickly consumed the garage and
 dwelling.
- Chief Drake and FF Nielsen attended the Fire Department Instructor's Conference (FDIC) in Indianapolis Indiana from April 26-28, 2017.
