Funding for servicing town hall air conditioning unit

The motion was made by Mr. Rideout to approve funding of \$300 for servicing the town hall air conditioning unit. Seconded by Mr. Straub. Motion carried 3 to 2. Mr. Ellick and Mr. Gunnell descending.

Approval of funding to reprogram fire department radios

The motion was made by Mr. Straub to approve funding of \$500 for the reprogramming of fire department radios. Seconded by Mr. Rideout. Motion carried 5 to 0.

Approval of funding for road repair to Simmons and Trenton Ave.

The motion was made by Mr. Rideout to approve funding up to \$61,000 for road repair to Simmons Ave. and Trenton Ave. Seconded by Ms. Zenker. Motion carried 5 to 0.

Authorization for help on township clean up days

The motion was made by Mr. Straub to approve paying Mr. Lavern Lanning and Mr. Nolan Ellick to assist in the clean up days at a cost of \$10 per hour. Seconded by Mr. Gunnell. Motion carried 5 to 0.

Authorization for copy machine lease/purchase agreement

The motion was made by Mr. Straub to approve signing a lease to own agreement with Michigan Office Solutions in the amount of \$376 per month for 60 months. Seconded by Ms. Zenker. Motion carried 5 to 0.

Authorization for funding for sand removal from and black dirt for the cemetery

The motion was made by Mr. Straub to approve funding up to \$500 for sand removal from and black dirt for the cemetery. Seconded by Mr. Rideout. Motion carried 5 to 0.

Authorization to purchase flags for cemetery

The motion was made by Mr. Rideout to approve funding up to \$300 for the purchase of flags for the cemetery. Seconded by Mr. Straub. Motion carried 5 to 0.

Additional funding for North Kent Transit Services

The motion was made by Mr. Rideout to additional funding in the amount of \$300 for the North Kent Transit, funding to be taken from the Community Block Grant funds. Seconded by Ms. Zenker. Motion carried 5 to 0.
