**Funding for MTA conference**

Motion by Mr. Straub to approve funding up to \$1,175.00 for Board members to attend the 2011 MTA conference in Grand Rapids. The motion was seconded by Mr. Gunnell and carried 5 to 0.

**Funding for repairs to property at 2391 19 Mile Road**

Motion by Mr. Straub to authorize up to \$4,500.00 for the repair to the property located at 2391 19 Mile Road. The motion was seconded by Ms. Zenker and carried 5 to 0.

**Funding for repairs to cemetery building**

Motion by Mr. Straub to approve funding up to \$500.00 for new roof on cemetery building. Mr. Gunnell seconded the motion. The consensus of the Board was that we should install a metal roof instead of shingles. The motion carried 5 to 0.

**Award snow plowing bid for 2010 - 2011**

Motion by Mr. Rideout to award contract to O'Dowd snowplowing for \$1,600.00 per season plus salt. Mr. Ellick seconded the motion. The motion failed 2 to 3 with Zenker, Gunnell & Straub voting no. A second motion was then made by Mr. Straub to award contract to Marty's Construction Services for \$2,275.00 per season plus salt. The motion was seconded by Ms. Zenker and carried 3 to 2 with Mr. Ellick & Mr. Rideout voting no.

**Set price for sale of fire truck**

Motion by Mr. Straub to set the price for the sale of the mini-pumper at \$85,000.00. The motion was seconded by Mr. Gunnell and carried 5 to 0.

**Approval of preliminary plans for new township offices/community room**

Motion by Mr. Rideout to approve the preliminary plans for the new township hall as presented. The motion was seconded by Ms. Zenker and carried 5 to 0.

**Authorization to solicit for bids for architect services**

Motion by Mr. Rideout to authorize the soliciting of bids for architectural services with a minimum of three bids to be obtained by the Supervisor. The motion was seconded by Ms. Zenker and carried 5 to 0.
