RESOLUTION NO. 23-10

**RESOLUTION TO ADOPT THE 2022 KENT COUNTY,
OTTAWA COUNTY, AND THE CITY OF GRAND RAPIDS REGIONAL HAZARD
MITIGATION PLAN**

WHEREAS, the Township Board of the Township of Solon recognizes the threat that natural hazards pose to people and property within our community;

WHEREAS, undertaking hazard mitigation actions will reduce the potential for harm to people and property from future hazard occurrences;

WHEREAS, an adopted Multi-Hazard Mitigation Plan is required as a condition of future funding for mitigation projects under multiple Federal Emergency Management Agency ("FEMA") pre- and post-disaster mitigation grant programs;

WHEREAS, Kent County, Ottawa County, and the City of Grand Rapids have prepared a Multi-Hazard Mitigation Plan for Kent and Ottawa Counties, which is named the Kent County, Ottawa County, and the City of Grand Rapids Regional Hazard Mitigation Plan;

WHEREAS, the Michigan State Police/Emergency Management Division and FEMA, Region V officials have reviewed the Multi-Hazard Mitigation Plan and approved it contingent upon this official adoption of the participating governments and entities.

NOW, THEREFORE, BE IT HEREBY RESOLVED AS FOLLOWS:

1. The Township Board hereby adopts the 2022 Kent County, Ottawa County, and the City of Grand Rapids Regional Hazard Mitigation Plan (including Solon Township, Grand Rapids and other surrounding communities) and in coordination with the counties of Ottawa and Kent, will submit this Adoption Resolution to the Michigan State Police/Emergency Management Division and FEMA, Region V officials to enable the final approval of the 2022 Kent County, Ottawa County, and the City of Grand Rapids Regional Hazard Mitigation Plan.

2. All resolutions or parts thereof in conflict with the terms hereof are rescinded, to the extent of said conflict.
