**Additional public comments:**

Several people spoke during the public comment period regarding data centers. Some of the concerns included, noise and light pollution, water usage and contamination, short life span of the centers, utility increases, longer power outages, no guardrails for AI, no protections for community, negative impacts to humans and animals, effects on hunting and fishing, PFAS. Others spoke to their trust in the Board but would like information. One resident stated that the community assumes the worst, but this Board has addressed serious noise violations in the Township, light pollution, and soil contamination in the past year stating the Board does have the best interests on the community at heart. They thanked the Board for their time and service.

Supervisor Ellick addressed the crowd stating that no one on this Board or the Planning Commission is receiving any kick backs of any kind. "I couldn't care less if I have a data center. Don't care one iota, one way or another, right now. Never have, never had the need for one, never even heard the word until last summer sometime." If you have questions, come in and meet with me.
