- **Ordinance to Rezone Areas near 17 Mile Road Between Algoma Ave and Division Ave as Recommended by the Planning Commission:**
A motion was made by Hoskins to approve the Ordinance to Rezone Areas near 17 Mile Road Between Algoma Ave and Division Ave. The motion was not supported.

- **Ordinance to Rezone Areas Along Algoma Ave Between Solon Ave and 17 Mile Rd as Recommended by the Planning Commission.**
A motion was made by Anielski to table both rezoning ordinances for 90 days and send them both back to the Planning Commission, seconded by Ellick.
