Sevey: Called for nominations for Secretary. (Sawade) nomination for Al Myers. (Myers) Accepted. Sevey: Called for motion to elect Al Myers as Secretary. Motion by Sawade, second by Tilburt; all Ayes, Motion Carried.

Agenda Item #2: Scheduled Public Hearing – Accessory Buildings Ordinance Amendment

Sevey: Called for public comment with explanation of procedures/proposal. With no public comment, public comment closed.

PC Discussion: (Tilburt) Wants to add the words, "wood structure" to the list. (*Sevey*) Called for motion to approve ordinance with amended list including "wood structure." Motion by Hoskins, second by Myers; all Ayes, Motion Carried.

Agenda Item #2: Scheduled Public Hearing – Kennels Ordinance Amendment

- Sevey: Called for public comment with explanation of procedures/proposal. *1: (Babcock, Vicky) Rules same as commercial kennels now? Excessive regulation; cats shouldn't be included; more than 3 animals should be allowed; foster animals shouldn't be included; barn cats should apply to this unless Right to Farm Act protects it. Referenced personal letter to Planning Commission. Submitted as Attachment #1A. *2: (Nix) Grandfathered in w/current animals; Will it be case-by case? Some cases understandable.
- PC Discussion: (Gross) Ordinance intended to be fair most cases based on complaint and confirmation. (Myers) Re: developments 2 dogs on a lot is a lot on a 1-acre lot. (Hoskins) Bylaws of most developments tell animal requirements. (Leisman) Regulations shouldn't restrict building within 200' of kennels. (Babcock) Could new buildings be put in within 200'? (Leisman) read ordinances/proposed changes. (Hoskins) Changes: puppy age from 6 months to 4 months, add verbiage that 200'/5 acres could be case by case.
- Sevey: Called for motion to accept changes to Kennel Ordinance. Motion by Myers, second by Hoskins. Ayes Myers, Sawade, Tilburt, Sevey, Hoskins, VandenBerg. Nays Babcock. Motion Carried.
