### New Business

#### • Authorize annual support payment to CSA P&R

A motion was made by Ellick to authorize payment of budgeted amount of \$5,000, seconded by Gunnell, The motion carried 4 to 1.

### • Authorize annual support payment to Solon Township Park - \$5,000

A motion was made by Poulsen to authorize payment of budgeted amount of \$5,000, seconded by Hoskins. The motion carried 5 to 0.

### • Authorize budgeted transfer to Fire Operating - \$88,244

A motion was made by Ellick to authorize transfer of budgeted amount of \$88,244 to Fire Operating, seconded by Poulsen. The motion carried 5 to 0.

### • Authorize budgeted transfer to Fire Capital - \$20,000

A motion was made by Hoskins to authorize transfer of budgeted amount of \$20,000 to Fire Capital, seconded by Gunnell. The motion carried 5 to 0.

### • Authorize budgeted transfer to Street Fund - \$171,156

A motion was made by Poulsen to authorize transfer of budgeted amount of \$171,156 to Street Fund, seconded by Gunnell. The motion carried 5 to 0.

# • Bio-Care NFPA 1582 exams with chest X-rays & drug screening - \$3950

A motion was made by Ellick to approve agreement with Bio-Care to provide exams, chest X-rays & drug screening, seconded by Hoskins. The motion carried 5 to 0.

#### • Target Solutions online Fire & EMS training - \$2039

A motion was made by Hoskins to approve agreement with Target Solutions for online FD training, seconded by Gerhardt. The motion carried 5 to 0.

#### • Foreclosed property on Stonecrest, Olin Lakes

A motion was made by Ellick to exercise first rights to purchase tax foreclosed property at 773 Stonecrest for \$4,170.21, plus pay 2017 tax bill, and title insurance as deemed necessary, seconded by Gunnell. The motion carried 5 to 0.

# • KCI Summer 2017 Tax Bills and newsletter – 2 bids

A motion was made by Gerhardt to accept proposal from KCI to print and mail Summer Tax notices and newsletter, seconded by Hoskins. The motion carried 5 to 0.

### • Resolution to collect school district property taxes in Summer 2017

A motion was made by Poulsen to approve resolution to collect Cedar Springs, Kent City, Grand Rapids Community College and Kent Intermediate School District taxes in Summer 2017, seconded by Gerhardt. A roll call vote resulted as follows:

Gunnel – Y; Hoskins – Y; Ellick – N; Gerhardt – Y; Poulsen – Y. The motion carried 4 to 1.

# • Township Hay and Top Soil

A motion was made by Poulsen to offer field of Hay on township property to highest bid received by May 25, seconded by Gerhardt. The motion carried 5 to 0. Will be advertised in Cedar Springs Post.

Top Soil from walking path will be used where needed on township property and the rest offered to residents.

**Discussion Items:** Clean-up of Stonecrest foreclosed property purchased (see above). <u>Motion by Ellick</u> to accept offer by Dan Vandenberg to dismantle and remove house for price of \$3,000 pending Quit Claim deed from County Treasurer, seconded by Gerhardt. Motion carried 5 to 0. Discussion of agreement to complete removal within 30 days of agreement.

Additional public comments: Jody Hall, talking for 7 residents in Olin Lakes area: Thank you for supporting option to remove unsafe house on Stonecrest. There are 2 other properties in the area under bank foreclosure. Bank won't allow anyone in to bid on one because of black mold problem. Other has a family member of owner working on Power of Attorney attempting to keep property in the family.

A motion was made by Mr. Gerhardt to adjourn, support by Mr. Poulsen. Motion carried 5-0. **Meeting adjourned @ 8:15 pm.**
