A motion was made by Ellick to adopt resolution as presented, seconded by Hoskins. Roll Call Vote: Hoskins – Y; Poulsen – Y; Ellick – Y. Motion carried 3-0.

Approve distribution of PC proposed Master Plan to Notice Group

A motion was made by Poulsen to approve distribution to Notice Group, second by Hoskins. The motion carried 3-0.

Acceptance of Automated Chest Compression Grant

A motion was made by Ellick to accept the approved Firehouse Subs Public Safety Foundation Grant for an automated chest compression device (ACCD), second by Hoskins. Chief Drake commented training is being scheduled. The motion carried 3-0.

• FD candidate Kolenda

A motion was made by Poulsen to hire Lee Kolenda as Firefighter, seconded by Hoskins. The motion carried 3 - 0.

Amend Resolution #17-19 regarding Property Transfer Affidavits

A motion was made by Poulsen to amend resolution 17-19 to remove wording "as amended, for those transfers which are exempt per MCL Section 211.27b. Be it Further Resolved that Solon Township may waive the penalty in those cases where a form is filed, seconded by Ellick. Roll Call Vote: Hoskins – Y; Poulsen – Y; Ellick – Y. Motion carried 3-0.

• New Computer for Fire Department Training software - \$990.25

A motion was made by Ellick to approve purchase of desktop computer for Fire Department, second by Hoskins. The motion carried 3-0.

A motion was made by Ellick to accept resignation, second by Poulsen. The motion carried 3-0.
