## • Dispatch Agreement

### • 2020 KC Fire Commission Assessment

A motion was made by Hoskins to approve payment for the 2020 Fire Commission Assessment in the amount of \$12,292.43, seconded by Stout. Motion carried 5-0.

# • FD Credit Card

A motion was made by Gerhardt to apply for the Visa Business Card for use by the Fire Chief with a limit of \$1000.00, seconded by Willoughby. Motion carried 3-2.

# • Generator Estimates

A motion was made by Ellick to accept the quotes from Cummins for generator repairs for a total of \$5,474.09, seconded by Stout. Motion carried 5-0.

### • Cyber Coverage

A motion was made by Stout to add cyber coverage to our annual insurance premium in the amount of \$839.00, seconded by Hoskins. Motion carried 5-0.

### • Trustee Pay

A motion was made by Ellick to pay Trustees \$50 for each additional meeting they attend not including Board or Staff meetings. Meeting pay will be approved each month by the Board, seconded by Willoughby. Motion carried 3-0 with Stout and Hoskins abstaining.

# • Resolution to Accept Written Appeals from Residents without a personal appearance.

A motion was made by Stout to adopt Resolution to approve Board of Review to accept written appeals from residents without a personal appearance, seconded by Gerhardt. On a roll call vote: Hoskins-Y; Willoughby-Y; Ellick-Y; Gerhardt-Y; Stout-Y. Motion carried 5-0.

# • Resolution for Poverty Exemption

A motion was made by Gerhardt to adopt Resolution for the Federal Poverty Income Standards for determining eligibility for homestead exemption from property tax, and to adopt guidelines for determining eligibility for the homestead exemption from property tax, seconded by Hoskins. On a roll call vote: Hoskins-Y; Willoughby-Y; Ellick-Y; Gerhardt-Y; Stout-Y. Motion carried 5-0. **Discussion Items:** The County has been working on tree cutting in preparation for work on 16 Mile.
