<u>Cedar Springs Public Library</u>: The library has had a busy month with the start of the summer reading program, a CTA visit, spring bingo, blood drive, friends of the library, library birthday party, and literacy carnival.

North Kent Community Enrichment: The voting of officers is happening at the July meeting. Have been discussing possibly changing the name, and changing by-laws to coincide with smaller number of representatives. Will be switching over to quick books program and leaning towards City of CS helping with books.

• Pictometery Invoice

A motion was made by Ellick to approve the invoice from Kent County for pictometery in the amount of \$3099.19, seconded by Willoughby. Motion carried 5-0.

• Zoning Enforcement Prospect: Ronald Perrin

A motion was made by Hoskins to hire Ronald Scott on a 90 day trial basis at \$18/hr, subject to a clear background check, seconded by Stout. Motion carried 5-0.

• Art Gerhardt Wages

A motion was made by Anielski to approve Art Gerhardt's contractual rate of \$50/hr for Treasurer training, seconded by Ellick. Motion carried 5-0.

• Vector Solutions Invoice:

A motion was made by Willoughby to approve the invoice from Vector Solutions in the amount of \$2244.80 for the fire department software, seconded by Anielski. Motion carried 5-0.

• MTA Invoice:

A motion was made by Hoskins to accept the MTA invoice for membership dues in the amount of \$4313.91, seconded by Willoughby. Motion carried 5-0.

Discussion Items:

Cedarfield: A motion was made by Anielski to vote for first right of refusal for the Cedarfield Septage, seconded by Hoskins. Motion failed 0-5.

Echo Park: Discussed possible solutions for marking the park, which is township property, so it is more clear to both visitors and those who live near the park. Board members will continue thinking about possible solutions.

Lawncare/Cemetery: Discussed the idea of buying a small tractor to use for lawncare and sexton duties.

Additional public comments: They have had issues getting a footing placed in the cemetery. Clerk will follow up with sexton.
